



2019/2020 Agricultural Lease Request for Bids

Open to Prairie Island Community members and the general public:

The Prairie Island Indian Community (PIIC) is seeking bids for two separate one-year, and one two-year agricultural leases within NW Goodhue County (Leases 1 and 2), and a property in southcentral Washington County (Lease 3). Maps identifying locations of lease lands will be available at the PIIC Administration Building through the Department of Land and Environment.

The leases are a fixed-per-acre rate and solely for agricultural purposes. The lease amount will not be adjusted if the lessee uses less than the noted acreage. Fifty percent (50%) of the submitted bid total must be paid to the PIIC Finance Department by January 11, 2019; the remaining 50% will be due in accordance with lease terms. If the initial payment is not received before the above date, the next bidder will be selected to provide the initial payment. PIIC requires a contract with the selected bids; the lease conditions are available upon request.
